Cllr Spence has spoken to the Land Registry about registering Council the ownership of the cemetery. No deeds are in existence but Cllr Spence has found reference to the purchase of the land in the minutes of 23 September 1908. It would be necessary to employ a solicitor in order to register the cemetery and the Parish field as property of the Council.

The proposals for the building of a solar farm in Marton was discussed. Cllr Ellis assured the meeting that consultations will take place before final decisions are made, giving local communities the opportunity to make the developers aware of any local land marks, special features, and so on. Good quality agricultural land will not be used.
